Following graduation, Quezada plans to get her MBA. Quezada's internship role will include learning about market research, engaging in social media outreach and website content along with event planning and participating in the bank's sponsorship committee.

**Carter Vidnansky** of Lake George, N.Y. will be working with the customer support operations department for his internship at BSNB. Going into his senior year at Siena College, Vidnansky is expected to graduate in May 2025 with a bachelor's degree in finance and a concentration in investment fundamentals. After graduating, Vidnansky plans to take the Chartered Financial Analyst (CFA®) Level 1 Exam. During his time at BSNB, he will be providing analysis and reporting on departmental productivity and trends. He will also compile statistics to analyze customer requests for service and support.
